### ORDER

As per the Government order read 1<sup>st</sup> paper above, it was ordered to implement the new system of e-TR-5 receipts with effect from 01.01.2020 and the old TR-5 receipts will not be valid after that. Then vide GO read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> above implementation of e-TR-5 receipts was extended up to 30.09.2020. Now vide letter read above Director of Treasuries has requested to defer the implementation of e TR5 Receipts for a six months due to various recent software issues and current COVID 19 scenario.

Govt have examined the matter in detail and are pleased to order that the implementation of the new system of e-TR-5 receipts is extended up to 31.03.2021 and the new system will be put in operation with effect from 01.04.2021 onwards only.

The Director of Treasuries should ensure the preparedness in this connection in consultation with NIC, Director of Printing and Stationery Controller and furnish an ATR to Government.
