### **Annexure**

#### **(Modifications to the regulations ordered as per GO(Rt) No. 404/2021/DMD dated 06.05.2021)**

1. Following Government of India establishments also are included in the exception category:

Petronet/LNG supply, Visa Consular Services/ Agencies, Regional Passport Offices, Customs Services,ESI services.

2. Following State Government establishments also are included in the exception category:

Transport Department (Motor Vehicle Dept and minimum bus service), Women and Child Department, Dairy Development Department, NORKA.

All the departments included in the excepted category shall engage only bare minimum staff to undertake COVID-19 containment related duties and other duties of exigent nature.

3. Following are included in the exceptions category of commercial and private establishments (item no. 5 of annexure to the GO(Rt) No.404/2021/GAD dated 06.05.2021)

xix. Restaurants will be allowed to open from 7 AM to 7.30 PM ,only to cater to home delivery/parcel of cooked food.

4. The following institutions included in exceptions of item no. 5 of annexure to the GO(Rt) No.404/2021/GAD dated 06.05.2021 shall function only on alternate days during lockdown namely -Monday , Wednesday and Friday : "Banks,Insurance,Financial Services,Capital and Debt market services as notified by SEBI and Cooperative credit societies"
5. Movement of bystanders to the patients to and from the hospitals is allowed showing the proof issued from hospital.
6. Advocates and clerks are allowed to travel to courts if physical sittings

are notified.

7. Following are included in the exceptions category of Industrial establishments (item no. 6 of annexure to the GO(Rt) No.404/2021/GAD dated 06.05.2021) v. Packing and packaging industrial units involved in packing of essential food,medical items and items for export.
